Police Pistol Combat Tournament Announcement

The Los Angeles Police Revolver And Athletic Club and LAPD Reserves are conducting Police Pistol Combat Tournaments at the Ben Clark Public Safety Training Center on the same weekend and simultaneously as a “Postal Tournament” at the Sacramento Sheriff Office Range.

The Tournaments will be conducted on Saturday, April 2nd & Sunday, April 3rd with the LAPRAAC Police Pistol Combat Tournament being fired first. The LAPD Reserve Police Pistol Combat Tournament will then be fired. By having back-to-back tournaments, shooters can compete in two tournaments in one day or fire one each day.

Each tournament will be offering the NRA Open Class Semi-Automatic Pistol Match, Open Class Revolver Match, Stock Service Semi-Automatic Pistol Match and Stock Service Revolver Match. Shooters can also sign up to fire the non-sanctioned California Distinguished Revolver and Semi-Automatic Pistol Matches.

These Tournaments are a great way for you to evaluate your skill level, identify needed training areas, and practice your handgun skills to keep you prepared for the ever-increasing dangers you face on the street and off duty.

First Time Shooters

You do NOT need any fancy gear or guns to start shooting these matches. Just bring your duty handgun, four magazines, holster & magazine pouch. There is nothing to memorize, the course will be announced as you shoot just like the stages during a qualification and fellow officers will gladly help you out. *You can even use your stock duty gun to fire the Open Class Division matches!* Challenge yourself and have fun at these matches.

Dates: Saturday, April 2nd & Sunday, April 3rd. The LAPRAAC Police Pistol Combat Tournament will be conducted first each day and the LAPD Reserve Police Pistol Combat Tournament will be fired after the first Tournament’s relays have completed.

Directions: From I-215 [SR-60], Exit Van Buren Blvd, Turn West onto Van Buren Blvd for 2.5 mi, Turn LEFT (South) onto Barton Rd for 1.0 mi, turn LEFT (East) at the first stop sign, which is Larry Parish PK way then follow the signs to the range. The range is located in the far southwest corner of the training center.

Governing Rules: Current NRA Police Pistol Combat Rules will govern throughout the Tournaments. All competitors are encouraged to review the current PPC rules. The NRA Police Pistol Combat Rule Book is available on-line at ppc.nra.org.

Eligibility: Open to any eligible law enforcement member as outlined in Police Pistol Combat Rule Section 2.4.

Registration: Will be done on-site. Please complete the Registration Form at the end of this announcement and bring it with you to speed your registration process.

All competitors **MUST** present the following items during Registration:

1. Valid Department or Agency Identification
2. Current Classification Card or current Temporary Classification Book unless they have not fired in a PPC Tournament before.

Lanes 1-9 will be utilized. If necessary an additional range will be used.

LAPD Reserve Police Pistol Combat Tournament – Saturday, April 2nd & Sunday, April 3rd
after the above Tournament is completed.

- Fees are the same as above.

Classification: Competitors will be entered using their current NRA Police Pistol Combat Classification of High Master, Master, Expert, Sharpshooter, Marksman, or Classified. Competitors with expired Classifications, new shooters with no Classification, or those without a Temporary Record Score Book will be registered in the High Master Class as required by PPC Rule 19.2.

Competitors may check their current NRA Classification at

LEcompetitions.nra.org. **Categories:** There will be no categories used in these Tournaments.

Targets: Official NRA B-27 targets will be used.

Scoring: Competitor scoring will be used. Pursuant to PPC Rule 14.2, NO competitor will score their own target, NOR may a competitor score the targets of a competitor from their same agency. If this cannot be avoided due to the Relay's makeup contact a Match Official to score the targets. PPC Rules prohibit the use of plug-type scoring gauges. Overlays and Eagle Eyes may be used by competitors.

Score cards must be signed and are FINAL once signed so **PLEASE** double check the recorded hits and values BEFORE signing.

Courses of Fire: To force reloading under time restraints and magazines are loaded with a maximum of 6 rounds. All times start with loaded gun in holster with hands at sides.

		<p>Stage 1: 7 yards, 12 shots double action standing without support. Time limit 20 seconds including time to reload.</p> <p>Stage 2: 25 yards, 6 shots kneeling; 6 shots standing left handed with support from behind left side of barricade, and 6 shots standing right handed with support from behind right side of barricade. All fired double action. Time limit 90 seconds, including time to reload.</p> <p><i>Change Targets</i></p> <p>Stage 3: 50 yards, 6 shots sitting; 6 shots prone; 6 shots standing left handed with support from behind left side of barricade and 6 shots standing right handed with support from behind right side of barricade. All shots may be fired single or double action. Time limit 2 minutes and 45 seconds including time to reload.</p> <p>Stage 4: 25 yards, 6 shots double action standing without support. Time limit 12 seconds.</p>
		<p>Match 6 is the Aggregate of the shooter's Open Class Revolver with a total possible score of 600 points.</p> <p>Match 13 is the Aggregate of the shooter's Open Class Semi-Automatic Pistol Match with a total possible score of 600 points.</p>
